Any reference to the sponsorship under this agreement must make it clear the sponsorship is with a division(s) or team(s) in the local Dixie Youth League only, and nor for Dixie Youth Baseball and Softball. Use of the Dixie Youth logo is prohibited, unless permission is expressly granted in writing by Dixie Youth Baseball.
