

West Springfield Little League Board of Directors/Dedicated Volunteer Application Instructions

What is the difference between a Board Member and a DV? The primary difference between the two positions is that only Board Members are allowed to vote on issues brought before the WSLI Board. DVs are encouraged to attend all Board meetings and provide insight and opinions. However, under Little League guidelines DVs do not vote. The DV position allows former BOD members to move to a less involved status within the league and still lend a helping hand.

Previous experience has shown that both WSLI and the individual are best served by a minimum two-year commitment for full Board Members.

What are the duties of a Board Member or DV? Board Members and DVs serve in a variety of areas, including fields and facilities improvement and maintenance, fund raising, sponsor solicitation, tryouts and draft operation, uniform and equipment procurement, special events, training programs, and publications. In addition, all Board Members and DVs are involved in registration activities and day-to-day league operation of both our Byron Avenue complex and our off-site fields. Board Members are also involved in the selection of league managers and coaches, the generation of local rules, and the organization and execution of post-season All Star teams. Beyond their assigned duties, Board Members are also expected to participate in monthly Board Meetings, where the general business of the League is conducted. DVs are welcome to attend these meetings but are not required to do so.

As a WSLI Board member or DV, you ARE West Springfield Little League. You influence all aspects of League operation and are an integral part of setting the tone and tenor of the league within the Springfield/Burke/Fairfax Station community.
