

WEST SPRINGFIELD LITTLE LEAGUE LIMITED WAIVER AND RELEASE

COVID-19 has been declared a worldwide pandemic by the Centers for Disease Control and Prevention. West Springfield Little League (“WSLL”) has established preventative measures and policies to reduce the risk of spread of COVID-19. WSLI cannot, however, guarantee that you, your children, or any other family member will not become exposed to or infected with COVID-19

This Waiver and Release of Liability Relating to Coronavirus/COVID-19 (“Waiver and Release”) is effective for the entire 2020 WSLI Fall Season, to include the scheduled season at the Intermediate, Majors, AAA, AA, and A divisions of play. This Waiver and Release encompasses any and all WSLI events and activities, to include, but not limited to practices and games (“WSLI Activities”).

I acknowledge that I have read each paragraph of the Waiver and Release

I acknowledge and understand the contagious nature of COVID-19, and I voluntarily assume the risk that I, my child(ren), and any other family member may be exposed to or infected with COVID-19 by participating in WSLI Activities, and that such exposure or infection may result in personal injury, illness, disability, or death.

I acknowledge and understand that I am agreeing to the terms set forth in the Waiver and Release as consideration for my child(ren) being permitted to participate in WSLI Activities.

I acknowledge and understand that the risk of becoming exposed to or infected by COVID-19 while participating in WSLI Activities may result from actions, omissions, or negligence of myself and others, including but not limited to, members of the WSLI Board of Directors, WSLI managers, coaches, umpires, and other volunteers, and all of WSLI’s program participants and their families. I acknowledge and understand that it is impossible to eliminate the risk that I, my child(ren), and/or other family members become exposed to and infected by COVID-19 when participating in WSLI Activities.

I, for myself, my child(ren), my family, heirs, and personal representatives or assigns voluntarily agree to assume the risk that I, my child(ren), or any other family member may be exposed to, and become infected by, COVID-19 when participating in WSLI Activities. I voluntarily agree to release WSLI and its officers, directors, agents, managers, coaches, umpires, volunteers, and insurers (the “Released Parties”) from and against any and all liability, claims, demands, actions, damages, or causes of action of any kind arising from or related to my child(ren), family member, or I being exposed to or infected by COVID-19 when participating in WSLI Activities.

The Waiver and Release is limited to claims premised on the negligence of the Released Parties; the Waiver and Release does not apply to claims that are based on the intentional conduct, or reckless disregard of the Released Parties.

I UNDERSTAND THAT BY ACKNOWLEDGING THIS WAIVER AND RELEASE, I AM RELEASING CLAIMS THAT I MAY OTHERWISE HAVE BEEN ABLE TO PURSUE, AND AM GIVING UP SUBSTANTIAL RIGHTS.
