PARENT CODE OF CONDUCT

1. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game and practice.
2. I (and my guests) will respect, and will not engage in any kind of unsportsmanlike conduct, such as booing, taunting, or using profane language or gestures with any official, coach, player, or parent.
3. I will never question, discuss, or confront coaches at practice or the game and will take time to speak with them at an agreed upon time and place. At a minimum, I will allow a 24 hour time period after the conclusion of practice or a game to seek a discussion with the head coach or as instructed by the head coach's team policy.
4. I will never question, discuss, or confront a League representative/volunteer at practice, the game or League event and will take time to speak with them at an agreed upon time and place. At a minimum, I will allow a 24 hour time period after the conclusion of a game or League event to seek a discussion with the head coach and then a League Representative in the following order: Football or Cheer Director, President or other Executive League Representative if Director or President is not available.
5. I will not ridicule or yell at my child or other participants for making a mistake or losing a competition.
6. I will promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win.
7. I will not encourage any behaviors or practices (e.g. rough play, dirty play, etc.) that would endanger the health and well-being of the athletes.
8. I will encourage the children to treat other players, coaches, officials, and spectators with respect regardless of race, creed, color, sex, or ability.
9. I will praise my child for competing fairly and giving their best effort.
10. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of a game or his/her performance.
11. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
12. I will learn the rules of the game and the policy of the league. If I have a question, I will contact the appropriate person following all time restrictions (i.e 24 hour waiting period) and method of contact (email, text or phone call).

13. I will encourage and support a sports environment for my child that is free from drugs, tobacco, and alcohol, and will refrain from use at all LYFA associated sporting events.
14. I will not send or reply to group emails or texts with disparaging remarks or language questioning or discussing coaching decisions or actions. All coaches are volunteers making an effort to coach the players.

Any concerns or questions should be discussed, texted, or emailed to the head coach and not broadcasted to other members of the team.

15. I will not send or reply to group emails or texts with disparaging remarks or language questioning or discussing League decisions or actions. All League representatives/volunteers are volunteers making an effort to run an organization that provides a league for your child(ren) to participate in. Any concerns or questions should be discussed, texted, or emailed to the proper league authority and not broadcasted to other members of the team or association.

3. Parental game suspension
