8. **Jamboree:** GEJFA rules state that we can participate with two Jamborees. Mt. Si holds their Jamboree on the 3rd Saturday of August. Adolfo contacted Mt. Si about the possibility of Redwolves and Mt. Si hosting every other year. Team photos can be taken at the Mt. Si event. Adolfo will confirm with Mt. Si that both groups would like to switch off on hosting.

9. **Flag Football/Cheer:** Adolfo reported that the cost of flag football is \$59 for the helmet used by other groups. The jersey that is used by tackle football is \$50. It was discussed that if the Board chooses a registration price of \$175, it may not cover all costs the first year, but will in consecutive years. Adolfo reported that flag football is a shorter season, with only 7 games. It was discussed that there is a possibility of flag cheerleaders with a limited outfit of a cheer skirt and a t-shirt.

10. **Helmet refurbishment:** It was reported that helmets were sent in to be refurbished for a cost of \$29 per helmet. Adolfo mentioned that the Board may want to look into possible inserts for some helmets to try. These inserts cost \$170 each.

11. **Andy Burns Reimbursement:** The Board decided to reimburse Andy Burns for funds he spend in 2018. It was decided by the board that from here forward, all reimbursements for the current year must be claimed by the General Board meeting.
