3. Treasurers Report:

In Tony Kevin's absence, Amy reported that Tony secured a CPA. He also gave Amy a Square reader to use for sponsorships. It was reported that there are possibly two incoming \$1000 sponsorships from parents. A \$150 gift certificate was donated from the Duvall Tavern.

4. Football Ops:

Brandon reported:

- **Varsity:** 20 players. Potential Volunteers (Jody Bickle volunteer coordinator, Ry Warden assistant coach, Jason Meats assistant Coach, and Jeff Rees, assistant coach).
- **JV** 14 players (no head coach, 2 assistants Chris Middleton, Rob Thompson)
- **Sophs** 12 players. Three assistant coaches including Brandon Savage, Erica is team parent, Brandon will follow up with Billy
- **Cubs:** 5 players
- **Rookies** 8 players. Travis Neubauer has volunteered to coach.
- **Flag** 14 players. There is one potential Coach however it appears we may have two teams.

Brandon will reach out to those who participated in parade and did not sign up yet. A discussion was made regarding the possibility of GEJFA offering a 7 on 7 tackle rookie team. However, the board will move forward with getting more signups for a full team.

Amy, reach out to Angela for Caedmon to see if she really intended him to be flag. He should be rookie. March 24, 2011 is cut off for flag. 5 age points = 57 points which is 2nd year rookie.

Cheer: Varsity: 9, JV: 17, Sophs: 11, Cubs 12, Rookies 5, Flag 1. The system seems to be wait listing people. Amanda has fixed this issue. Brandon and Amanda will get together to match cheer up to football teams.

Further discussion was had regarding practice times, specifically the overlap of 15 minute time. Tony O. mentioned that he would have the older teams begin warmup at 6:45. The practice times will be flexible during the season.

The board discussed how the field will be divided up for practice times. Possibility of using grass field for flag as they are one night a week. 6:45-8:45 for JV and Varsity.

5. Equipment Manager:

The board discussed June 15th 9-11am and 19th 6-7:30.

Ann requested that all jerseys are marked at try-on so it will be clear which size the jerseys are. Tony O will contact Cloud 9 to get sample sizes for fittings.
