PLAYER PARTICIPATION WAIVER/RELEASE

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization (WHO), Centers for Disease Control and Prevention (CDC) and the Iowa Department of Public Health (IDPH). COVID-19 is extremely contagious and is believed to spread mainly from person to person, through respiratory droplets produced when an infected person breathes, talks, coughs or sneezes. These droplets can land in the mouths, noses and/or eyes of people who are nearby or possibly be inhaled into the lungs. Spread is more likely when people are in close contact with one another (within about 6 feet). As a result, federal, state, and local governments and health agencies have recommended social distancing and limiting the congregation of groups of people.

Ankeny Junior Football, Inc. ("AJF") has put into place preventative measures in an attempt to reduce the spread of COVID-19; however, AJF cannot guarantee that you, your child(ren) or others will not become infected with COVID-19. Further, participating in and/or attending AJF events and activities could increase you, your child(ren)'s or others' risk of contracting COVID-19.

In consideration of my son/daughter being allowed to participate in any way, in any activities related to, hosted by or offered by AJF, I understand, acknowledge, appreciate, and voluntarily agree that:

1. Participation in AJF activities can involve significant risk of potential serious illness, injury or death.
2. Participation in AJF activities can include possible exposure to and illness from infectious diseases including, but not limited to MRSA, influenza, COVID-19 and other diseases. While adherence to particular rules and requirements may reduce the risk of possible exposure, the risk of serious illness, temporary or permanent bodily injury, disability and/or death remains.
3. The risk of becoming exposed to or infected by COVID-19 while participating in AJF activities may result from actions, inactions, omissions or negligence of myself or others, including, but not limited to, AJF board members, volunteers, employees, and AJF participants and their families and friends.
4. I voluntarily assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), myself or others; including, but not limited to personal injury, disability, illness, death, damage, loss, claim, liability, or expense of any kind that I, my child(ren) or others may experience in connection with my child(ren)'s participation in AJF activities.
5. On my behalf, and on behalf of my child(ren), our heirs, successors, assigns, and personal representatives, hereby release and forever discharge, covenant not to sue, and hold harmless AJF, its board members, directors, officers, members, managers, employees, volunteers, agents, representatives, attorneys, affiliates, subsidiaries, predecessors, heirs, successors and assigns (collectively, the "AJF Released Parties") from any and all damages, losses, claims, demands, liabilities, obligations, costs, expenses, actions and causes of action which the undersigned or any of their children, heirs, successors, assigns or personal representatives may now have or claim to have against any of the AJF Released Parties, whether in tort, in contract, or otherwise, and whether presently known

or unknown, matured or contingent, liquidated or unliquidated, arising from, in connection with, or in any way related to participation in AJF activities (“Claims”).

6. I understand and agree that this Waiver/Release includes any Claims based on the actions, omissions, or negligence, of any kind, of the AJF Released Parties, whether a COVID-19 infection occurs before, during, or after participation in AJF activities, events or programs.
7. This Waiver/Release and all questions relating to its validity, interpretation, performance and inducement shall be governed by, construed, interpreted and enforced in accordance with the substantive laws of the State of Iowa. The undersigned further agrees that any action brought to enforce or interpret this Waiver/Release, or any part thereof, shall be brought in the Iowa District Court for Polk County.
8. In any suit or action brought to enforce this Waiver/Release, reasonable attorney fees and costs shall be awarded to AJF.
