## **ZERO TOLERANCE**

**IMPLEMENTED 4/ 10/20 17 WITH THE PURPOSE OF UPHOLDING A HEALTHY AND ENJOYABLE ENVIRONMENT FOR THE ENTIRE COMMUNITY OF TOWNS COUNTY AND PARTICIPANTS IN THE PROGRAMS OF THE TOWNS COUNTY PARK AND RECREATION DEPARTMENT:**

**POSITIVE CHEERING BY PLAYERS, COACHES, AND SPECTATORS IS ENCOURAGED. ANY NEGATIVE CHEERING MAY RESULT IN A WARNING AND/OR REMOVAL FROM THE SITE. NO ARTIFICIAL NOISE MAKERS SHALL BE ALLOWED IN THE DUGOUTS, BLEACHERS, SEATS, OR STANDING AREAS AROUND THE PERIMETER OF THE PLAYING FIELD OR COURT IN ALL YOUTH AND ADULT SPORTS.**

- PLAYERS, MANAGERS, COACHES OR SPECTATORS EJECTED FROM A GAME SHALL BE SUSPENDED FOR THE CURRENT GAME AND THE NEXT GAME. ANY PERSON EJECTED WILL BE ON PROBATION FOR ONE YEAR.**
- ANYONE GUILTY OF PROFANITY (VERBAL OR NONVERBAL) AGAINST OTHER PLAYERS, COACHES, SPECTATORS, OFFICIALS OR STAFF SHALL BE SUSPENDED FOR THE CURRENT GAME AND THE NEXT GAME. ANY PERSON EJECTED WILL BE ON PROBATION FOR ONE YEAR.**
- ANY PERSON GUILTY OF MAKING THREATENING GESTURES OR INTIMIDATING ACTIONS AGAINST OTHER PLAYERS, COACHES, SPECTATORS, OFFICIALS OR STAFF SHALL RECEIVE A TWO GAME SUSPENSION, PROBATION FOR ONE YEAR, AND POSSIBLE SUSPENSION INDEFINITELY.**
- PLAYERS, MANAGERS, COACHES OR SPECTATORS GUILTY OF FIGHTING BEFORE, DURING OR AFTER A TOWNS COUNTY RECREATION DEPARTMENT SANCTIONED EVENT SHALL RECEIVE A TWO GAME SUSPENSION. PLAYERS, MANAGERS AND COACHES MAY BE WITHDRAWN FROM THE PROGRAM FOR VIOLATING THIS POLICY.**
- ANYONE GUILTY OF PUSHING, STRIKING OR ANY OTHER PHYSICAL CONTACT AGAINST ANY PLAYER, COACH, SPECTATOR, OFFICIAL OR STAFF SHALL RECEIVE A MINIMUM ONE YEAR SUSPENSION TO A MAXIMUM LIFETIME SUSPENSION.**
- IF A COACH OR SPECTATOR RUNS ONTO THE FIELD/COURT DURING A CONTEST OR INCITES HIS/HER FANS TO BECOME DISORDERLY DURING A CONTEST, THE VIOLATOR WILL BE SUSPENDED FOR TWO GAMES AND ONE YEAR PROBATION AND/OR SUSPENSION FOR THE REMAINDER OF THE SEASON(S).**
- NO USE OF ALCOHOL ON PARK PREMISES.**
- VIOLATIONS OF ANY OF THE ABOVE RULES WILL RESULT IN IMMEDIATELY LEAVING THE PREMISES ENTIRELY WITHOUT VISUAL OR VERBAL CONTACT WITH THE TEAM FOR THE ENTIRE SUSPENSION.**

**\*TOWNS COUNTY PARKS AND RECREATION DEPARTMENT RESERVES THE RIGHT TO IMPOSE A ONE YEAR TO A LIFETIME SUSPENSION FOR VIOLATION OF ABOVE RULES, FURTHER, THE TOWNS COUNTY RECREATION DEPARTMENT CAN IMPOSE ANY LENGTH BAN FOR ANY REASON DEEMED APPROPRIATE.**
