## Coaches' Code of Ethics

I hereby pledge to live up to the Code of Ethics set forth by the Milford Mustang Junior Football and Cheer League. The coach(s) must represent the best leadership. The coach(s) conduct is always under scrutiny. They must, at all times, be a role model for their players. Their actions affect their team, parents and fans. In line with this, the League requires the following standard of conduct from all of its coaches:

- 1) The coach will always keep the health and welfare of his/her players foremost and will remove any player from a game, practice or competition if an injured or health is in doubt.
- 2) The coach will always strive to set an example for their players "on and off" the field. Appropriate dress, demeanor, and language will be used at all times!
- 3) The coach will not berate a player in front of teammates, parents or fans.
- 4) The coach will not berate or criticize game/competition/board members and will accept their decisions as fair.
- 5) As a coach I will place the emotional and physical well-being of my players ahead of a personal desire to win.
- 6) I will treat each player as an individual, remembering the large range of emotional and physical development for the same age group.
- 7) I will do my best to provide a safe playing situation for all my players.
- 8) I will promise to review and practice the basic first aid principles needed to treat injuries of my cheerleaders.
- 9) I will do my best to organize practices that are challenging and fun for all my players.
- 10) I will lead by example in demonstrating fair play and sportsmanship.
- 11) I will provide a sports environment for my team that is free of drugs, tobacco, and alcohol, and I will refrain from use or arriving impaired at all youth sports events.
- 12) I will be knowledgeable in the rules of each sport that I coach, and I will teach these rules to my players.
- 13) I will use those coaching techniques appropriate for each of the skills I teach.
- 14) I will remember that I am a youth sports coach, and that the game is for children and not adults.

## AUTHORITY TO CONDUCT BACKGROUND CHECK / Terms of Service

As a volunteer applicant for the Milford Mustang Junior Football and Cheer League, I understand that I must submit a MANDATORY BACKGROUND CHECK FORM and I authorize a complete background investigation to determine my qualifications to participate as a youth volunteer in the Milford Mustang Junior Football and Cheer League. I understand that said background investigation is being conducted solely for the purpose of protecting the children in the program, and that all information will remain confidential in accordance with the law. I understand that misrepresentation or omission of facts is just cause for non-appointment as a volunteer. If I am appointed as a volunteer coach or assistant coach, I agree to abide by the Code of Conduct and by-laws of the Milford Mustang Junior Football and Cheer and the LCAJFL. I also agree to fulfill my volunteer responsibilities to the best of my ability. I may be dismissed at any time during the season for failure to comply with any part of this agreement. Following the approval of a candidate's application and a background check, a list of approved candidates will be created. Variable roster size is factored into the decision of how many coaches are selected at each

level. All coaching assignments and appointments are subject to approval of the executive board. I hereby certify that the facts set forth in this coaching application are true and correct to the best of my knowledge. I understand that if I falsify statements on this coaching application, I may not be considered for coaching duties. I hereby authorize the Milford Mustang Junior Football and Cheer League or its representatives to conduct an investigation into my background history to verify the above information.
